Project Overview

The City of Colby seeks funding from the U.S. Federal Aviation Administration for funding available through the Airport Infrastructure Grants (AIG) program for their Hanger Construction – Design Only project which includes designing a 100×120 box hangar to increase aircraft storage capacity and support transient jet traffic during inclement weather conditions.

This opportunity is a formula IIJA program with a local match requirement of 5% of the total project cost. The entity is requesting \$9,513.00 from the Build Kansas Fund, and is providing a local match of \$501.00. This request has the potential to unlock \$190,266.00 in federal funds, for a total project cost of \$200,280.00.

The deadline was June 30, 2025, and this Build Kansas Fund application was received on June 13, 2025.
